

Summary of the Settlement: Ocwen agreed to establish a Settlement Fund of \$17,500,000 to pay Settlement Class Members who make valid, timely Claims; pay service awards to the three Class Representatives; pay attorneys' fees and costs; and pay Settlement Notice and Administrative Costs. Plaintiffs will request up to \$25,000 each in service awards, and up to \$5,833,333.33 in attorneys' fees, plus costs. How Can I Get a Payment? To get a payment you must submit a Claim Form. To make a Claim: **(1)** fill out, sign, and mail this Claim Form back; **(2)** submit a Claim online at www.OcwenTCPASettlement.com; **OR (3)** print and complete the form from the Settlement Website and mail to Ocwen TCPA Settlement Administrator, P.O. Box 3775, Portland, OR 97208-3775. Each Settlement Class Member who submits a valid and timely Claim Form will receive a *pro rata* cash award. Settlement Class Members who received calls on more than one cell phone may submit one Claim per cell phone number, up to three. Class Counsel estimate that the amount of the cash award will be \$60, based on a ten percent claim rate. The deadline to file a Claim is **February 19, 2018**. If you make a Claim, you give up the right to sue separately for an order prohibiting more calls and damages of \$500 per call, or \$1,500 per call made willfully. This settlement offers less money than you could get on your own, but removes the burden, expense and risk of prosecuting your own case. This process takes time.

Do I Have a Lawyer? Yes. The Court appointed Burke Law Offices, LLC; Terrell Marshall Law Group PLLC; Ankorn Law Firm PLLC; Heaney Law Firm, LLC; and The Cabrera Firm, APC as counsel for the Settlement Class. They will be paid from the Settlement Fund. Alternatively, you may enter an appearance through your own attorney.

Your Other Options. If you do not want to be legally bound by the Settlement, you must exclude yourself by **February 19, 2018**. If you do not exclude yourself, you will release any claims you may have, as more fully described in the Settlement Agreement, available at the settlement website. You may remain a Settlement Class Member and object to the Settlement by **February 19, 2018**. You may choose to pay for and be represented by your own lawyer. The website explains how to exclude yourself or object.

Final Approval Hearing: The judge scheduled a hearing for **April 5, 2018, at 9:30 a.m.** in Courtroom 2103 of the U.S. District Court, Northern District of Illinois, 219 S. Dearborn St., Chicago, IL 60604, regarding whether to give Final Approval to the Settlement, including the amounts of any attorneys' fees, costs, and Class Representative awards. The hearing may be changed without notice. **It is not necessary for you to appear at this hearing, but you may attend at your own expense.**

LEGAL NOTICE

Snyder v. Ocwen Loan Servicing, LLC,

No. 1:14-cv-08461 (N.D. Ill.)

A settlement has been proposed in this lawsuit pending in the U.S. District Court for the Northern District of Illinois (“Court”).

This case claims that Ocwen Loan Servicing, LLC (“Ocwen”) violated the Telephone Consumer Protection Act by calling cell phones using an automatic telephone dialing system without consent (“Automatic Calls”). Ocwen denies it did anything wrong.

Who Is Included? You may be in the Settlement as a “Settlement Class Member” if you received one or more Automatic Calls to your cell phone from Ocwen between October 27, 2010 and October 6, 2017. If you received this notice, Ocwen’s records suggest that you are very likely a Settlement Class Member.
